The Ada Public Library Board of Trustees met in regular session on Tuesday, December 17, 2024 at 8:31 a.m.

Roll Call: Bethany Spieth, present; Ann Donnelly Hamilton, present; Jenny Gargac, present; Brandon Fauber present; Robert Alexander, present; Melanie Weaver, present; Aaron Morford, absent.

The minutes of the November 19, 2024 Regular Meeting was approved by the Board.

FISCAL OFFICER REPORTS:

The Fiscal Officer presented the November Financial Report which includes a Receipts report, Payment Report, Income Statement, and Bank Reconciliation (see attachment A).

After discussion, Brandon Fauber moved, seconded by Robert Alexander to accept the fiscal officer's reports. Roll call: All yea. Motion carried.

NEW BUSINESS:

STAFF BONUS GROSS \$160 BONUS:

Jenny Gargac moved and Melanie Weaver seconded to approve a one-time \$160 gross bonus to each library employee before December 30, 2024. Roll call: All yea. Motion Carried.

EXECUTIVE SESSION. Motion made may by Brandon Fauber and seconded by Melanie Weaver to adjourn into executive session at 9:09a.m. to consider the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of a public employee or official or to consider the investigation of charges or complaints against a public employee, official, licensee, or regulated individual, unless the employee, official, licensee, or regulated individual requests a public hearing. All voted yes on the roll call vote.

Ann Donnelly Hamilton left the meeting at 9:50am.

EXECUTIVE SESSION. Motion was made by Brandon Fauber and seconded by Melanie Weaver to come out of executive session at 9:56am. All voted yes on the roll call vote.

The Board discussed staff evaluations. Brandon Fauber moved that the 2025 salary increases be as follows: For employees who receive a ranking between 2.5 - 3.4 on their end-of-year evaluation, a salary increase of 2.7% (base). For employees who receive a ranking between 3.5 – 4.4 on their end-of-year evaluation, a salary increase of 3.7% (high merit). For employees who receive a ranking between 4.5 - 5 on their end-of-year evaluation, a salary increase of 5% (outstanding). This increase will begin on the January 10, 2025 paycheck and excludes all employees hired during the calendar year 2024. Melanie Weaver seconded. The Roll Call vote was follows: All voted yes on the roll call vote.

BOARD CONTRIBUTIONS TO SALARIED EMPLOYEES' HSA ACCOUNT. After discussion a motion was made by Brandon Fauber and seconded by Robert Alexander to approve a \$1,500 contribution to Rhett Grant's HSA account to offset the cost of the high deductible health insurance plans. Roll call: All yea. Motion Carried.
